Identification data of the appliances:

Stoves trade names: Avila, Avila T, Getaria, Mangala, Tudela, Meru, Luanco, Lugo, Tala

The wood fired stoves are intended for local heating of rooms in residential dwellings, cottages or farm houses. The appliances are manufactured of a sheet steel. The surface is protected by a heat resistant flat varnish; the fire chambers are lined with fireclay bricks; the bottom of the fire chambers are fitted with removable grids; the fire chambers are provided with a glassed door; the stove design includes a separate inlet for the primary and secondary air.

More detailed description of the fireplace is given in the instruction manual.

The evaluation of the sample of the appliance was carried out in accordance with the Government Act no.190/ 2002 Coll., § 5, Section1, letter b.
